Annual Report Oxford College Library 2019-2020

Mission Statement

The library offers a powerful combination of traditional and digital resources, student-centered spaces, virtual services, and a personal commitment to excellent service. As an academic and social hub of the Oxford College campus, the library organization dedicates its work to the achievement and success of our students, faculty, and staff both in-person and virtually. Within an inclusive and supportive environment, the library provides agile services, information literacy instruction, learning and research opportunities, and preservation of Emory's history for Oxford College as a part of the larger University.

- > Build a more inclusive and transformative academic and social environment;
- Fully integrate the library's role into the teaching, learning, technology, research, and personal enrichment of the Oxford College community;

Overview

Through dedicated, highly collaborative, and effective teamwork, the library organization made significant progress on library goal areas in support of the College's strategic plan initiatives and the Emory Libraries Roadmap. To ensure that Oxford students, faculty and staff have full access to the rich resources, technologies, systems, and services of the Emory Libraries, the librarians and staff are involved fully in important and wide-ranging committee work as evidenced in Appendix A. This extensive day-to-day work ensured the effective and efficient operation of the library throughout the year. Most notable this year, the libraries completed the first phase of the Emory Digital Collections repository that included Oxford's Asian Artifacts Collection and implemented Aeon, an integrated archives and special collections request system.

The library accomplished substantial work documented in this annual report due to the committed and creative work of existing staff and the addition of three, highly qualified, librarians who are integral to the achievement of the library's top priorities: library research instruction and faculty research support. Adrienne Button, Head of Teaching and Outreach, Anne Le-Huu Pineault and Paige Crowl, Teaching and Learning Librarians, made it possible for the library to connect a librarian with each Discovery Seminar to integrate information literacy as one of three learning outcomes for the course.

Unfortunately, we lost three employees during the year for different reasons. Marvlyn Corbin retired from the University again in February 2020 after three years of service as the library's Administrative Assistant and thirty-three years in Oxford's development office as Associate Director of Development. Chaundria Campos left her position as Late Night Library Specialist in June 2020 after a year and half of

service and China Redman, Circulation Services Coordinator, resigned her position in August 2020 with three years of service. We hired a record number of student employees, 46, and they contributed much to the overall success of day-to-day library operations. To view library organization chart see Appendix B.

For the first time ever, we were able to retrieve EZProxy data to show the use of library electronic resources by Oxford students, faculty, and staff separated from the rest of Emory users. Data showed a 4.5% increase in unique logins to library databases from the previous academic year. The data showed a 40.7% increase for Oxford faculty users and a slight decrease of 3.9% for student users. 8,818 students, 2,652 faculty, and 546 staff (some individuals more than once) completed unique sessions with a total of 189,488 total Oxford clicks or actions by content types that included abstracts, articles, books, reference, search, and table of contents. Due to the COVID-19 virus that necessitated students attend class remotely from home after spring break, the annual library attendance dropped from 168,042 to 128,091. We were not able to determine the impact of the new student center on library usage due to the sudden move to remote learning. Information desk questions dropped slightly from 2,594 to 2,355. Circulation of library material dropped from 30,637 to 20,511. However, use of Overdrive electronic books continued to increase with 12,635 checkouts and 1,912 unique users that included other Emory patrons. In addition, website page views increased from 77,015 to 91,787. Other annual library statistics are located in Appendix D.

As soon as the University switched to remote learning in March, the library staff implemented enhanced virtual research services to reduce the negative impact on students and faculty. We developed remote guides for faculty and students, provided extensive virtual information services, made additional electronic book purchases, and delivered access to electronic textbooks via *Vital Source* and *Redshelf* platforms.

Library Goals Accomplishments 2019-2020

Goal: Enhance the Research Practices program to support the Oxford College strategic plan and developments in information literacy in higher education.

The library hired Adrienne Button, the new Head of Library Teaching and Outreach and the leader of the Research Practices Team in August 2019. The Research Practices team successfully collaborated with faculty instructors for the 30 Discovery Seminars in the fall semester. We assigned each faculty member teaching a Discovery Seminar a personal librarian. In response to an introductory email from their personal librarian, 22 faculty members requested library instruction sessions for their seminars. Eight of these faculty requested scaffolded instruction of two or three sessions, resulting in 32 Discovery Seminar library sessions, reaching about 350 first-semester students.

In addition, librarians created customized research guides highlighting course-relevant skills for all Discovery Seminars and several faculty members embedded these guides into their Canvas course pages. The librarians were pleased to participate in the fall and summer Discovery Seminar Discussion Group and were available to offer suggestions for alternative research assignments and to answer questions about meeting the information literacy student learning outcome for the course. In addition to our work with the Discovery Seminars, the Research Practices Team taught 187 classes for a wide variety of disciplines and reached 2693 students. Some students participated in more than one library session. Furthermore, the team conducted 286 individual research consultations. The team successfully collaborated with Oxford College faculty and staff to create several online modules to provide a flipped-classroom learning experience tied to the *Framework for Information Literacy in Higher Education*.

The Research Practices team members also developed course-specific student research guides and modules to embed into Canvas after the move to remote instruction. For example, Vanessa Garofalo created a series of scaffolded, online modules for English 185 courses that allowed for flipped-instruction and both synchronous and asynchronous guided research support. Further, the team collaborated with archivists from Emory's Manuscript, Archives and Rare Books library to expose Oxford students to the rich special collections resources held by the University.

Librarians created research guides that focused specifically on copyright, fair use, permissions, and appropriate attribution for students creating ePortfolios. The Research Practices team worked to expand its expertise in this area this year by attending a workshop on *Best Practices for Copyright* led by Melanie Kowalski, a Copyright and Scholarly Communications librarian from the Atlanta campus.

A subgroup of Research Practices librarians formed a LibGuides working group. This working group studied best practices related to the creation and marketing of customized library research guides for various subjects and specific courses. That group continues to work on creating standardized "look and feel" style guidelines, accessibility, and a toolbox for creating library online research guides. The move to remote teaching in March 2020 necessitated the postponement of plans for conducting user experience surveys and focus groups.

Adrienne Button, Vanessa Garofalo, Anne Le-Hu Pineault, and Paige Crowl presented a workshop on designing learner-centered research guides at the *Georgia International Conference on Information Literacy*. Ellen Neufeld and Jessica Robinson presented on the library's LibCon orientation event at the Atlanta Area Bibliographic Instruction Group annual meeting. In addition to these scholarship and professional development activities, the Research Practices team participated in a half-day best practices retreat in January 2020 that covered various ways to improve information literacy, library teaching, learning, and assessment.

Goal: Enhance support for current and new faculty research and scholarship.

As a top priority, the personal librarians provided extensive research support for the faculty throughout the year across a variety of disciplines. For example, the librarians:

- Located books, electronic books, articles, films, and other resources
- Acquired new materials relevant to faculty research
- Assembled subject bibliographies
- Compiled comprehensive literature reviews
- Provided copyright and citation support
- Assisted faculty student research assistants and demonstrated best practices for complex research assignments

Goal: Collaborate with the Oxford College Writing Program, Academic Technology Department, Oxford College Center Teaching and Scholarship (OCTS), and the other Emory Libraries to support strategic plan initiatives and improve library and technology services for students and faculty.

The Research Practices team successfully collaborated with the Writing Center to design and deliver workshops on visual resources for Writing Center consultants; and, librarians participated in a series of Write-In events in the Center.

Working with the Oxford Center for Teaching and Scholarship, the librarians created an extensive library module for the Oxford College Online Teaching (OCOT) faculty development workshops to support the necessary move to online teaching for the fall. We embedded this module into the Canvas Faculty Training Resources course and included sections on the foundations of information literacy, a literature review on student research habits, content and resources that faculty can embed into their courses, and additional services and resources that the library provides to support student learning and student success. We received extremely positive faculty responses to this module and the accompanying workshop, as evidenced in the module discussion boards, homework reflections, and recorded/transcribed synchronous workshop sessions.

In addition, the Dean of the Library, Archives and Special Collections Coordinator, Oxford's Director of Communications, and Manager of Technology Infrastructure coordinated the sunset of the College's shared photo repository. After the Communications staff selected evergreen images to be stored in their SmugMug account, the Archives Coordinator and Senior Library Specialist selected content to migrate and preserve in the Emory Libraries' Digital Asset Management System (DAMS). The project results included removing nearly 27,000 duplicate files from an outdated shared campus file server and allowed OCIT to move forward with its decommissioning plan for the server.

The Teaching & Digital Projects Librarian, Vanessa Garofalo, partnered with the Emory Center for Digital Scholarship, Oxford Academic Technology, and faculty to lead digital scholarship initiatives including the <u>U.S. Mosque Controversies</u> digital archive, which is hosted on the Omeka content management platform. The U.S. Mosque Controversies archive documented cases of anti-Islam controversies in the Atlanta metro area and across the United States. The project is a collaboration with Dr. Florian Pohl who submitted the project for the 2019 Teaching and Learning with Technology Institute (TLTI). Dr. Pohl used the archive in his fall 2019 Discovery Seminar course in which students learned how to conduct research suitable for a digital archive through a series of three hands-on library instruction workshops. The Oxford College Library and Dr. Pohl continued to collaborate on this initiative for the 2020 Summer Undergraduate Research Experience (SURE) and the project team grew to include Teaching and Learning Librarian, Anne Le-Huu Pineault. The library provided research support for Dr. Pohl's SURE student and Oxford Research Scholar, who also worked on the project.

The library continued support of the <u>Archive of Personal Digital History (APDH)</u> using Omeka. The APDH contains transcripts and photographs of a series of interviews conducted in the fall of 2018 by students in Dr. Gwendolynne Reid's Discovery Seminar. Library support of this archive will continue in Dr. Reid's fall 2020 Discovery Seminar.

Goal: Collaborate with other Emory Libraries on the development of the Emory University Archives and Digital Library Program to expand access for students and faculty to the extensive digital resources of the libraries.

The Asian Artifacts collection is now publicly available as one of three collections included in the beta launch of the Emory Digital Collections site. The collection served as a model for future digitization projects involving multiple images of 3D objects, incorporating 191 images of 61 artifacts. Faculty and students will be able to use the images and additional metadata made available due to the Digital Library Program initiative in various linked data projects, including enhancing existing digital projects based on the collection. In addition, faculty and librarians may easily integrate the images into library instruction around digital primary source analysis, visual literacy, metadata creation, and research of Asian cultures and Emory history.

Digitized yearbooks will be an important resource for students regularly researching the history of the Oxford College campus in several history, social science, and humanities courses. Seventy-seven volumes from Oxford's collection are included in the planned re-launch of the Emory University yearbook collection on the Emory Digital Collections site in fall 2020.

The Emory Libraries realigned the digitization program over the course of the year to address the additional work capacity of the digitization staff. Project approval and prioritization will now occur on an annual basis; and, Oxford plans to propose *The Emory Phoenix* and *The Oxford Spokesman* for digitization during the 2020-21 cycle and the migration of the Early Emory Class Photograph Collection.

Dr. Dobbin-Bennet expressed interest in migrating her Oxford Research Scholars project from Scalar to Omeka. Kerry Bowden, Archives and Special Collections Coordinator developed a migration plan to implement when the project resumes. The migration plan entails mapping metadata to archival images now preserved in the Digital Asset Management System (DAMS). The migration process presents opportunities for students to gain experience in digital preservation, exhibits, and a deeper understanding of the digital object lifecycle.

While Tasha Dobbin-Bennett's collaboration with the library was on hiatus, the work of previous cohorts of Oxford Research Scholars involved in the Visual Narratives of Early Emory Student Life project gained accolades and continued to evolve. Tiera Ndlovu's award-winning research was the subject of an article in the *Emory Libraries Magazine*; and, she expanded on her work in the Mellon Mays Undergraduate Fellowship program.

The donation of Super 8 films shot by the late Reverend John Tate prompted emergency digital preservation of the collection. Once digitized, the archives team identified content related to the Oxford College classes of 1967-1972. Kerry Bowden worked with Advancement and Alumni Engagement staff to provide secure streaming access of selected films to alumni interested in incorporating the film into future projects for reunions and other alumni gatherings.

The Archives Team collaborated with other library staff to research and source content for a poster to commemorate and honor the 50th anniversary of the first African American graduates of Oxford College.

Angela Jinks Slaughter, the sole surviving first African American graduate, was delighted with the project and requested copies to share with the families of her classmates.

Throughout fall 2019, the Oxford community enjoyed the library's installation of the *Still Raising Hell* exhibition of the African American art collections of Camille Billops and James Hatch, held by the Rose Library. Faculty designed lessons and assignments around the content of the exhibition and allowed students to engage directly with the legacies of these two influential collectors.

The *Framing Shadows* exhibition, installed in January 2020, presented further opportunities for campus engagement, with 50 plus guests attending the opening talk given by curator Professor Kimberly Wallace-Sanders. As the pandemic unfolded, Emory Libraries invested resources in adapting *Framing Shadows* as its first full-fledged virtual exhibit, allowing the Emory community to continue to engage with the images of African American nannies and the research Dr. Wallace-Sanders featured in her most recent and forthcoming books. The library planned a virtual Lyceum lecture with Dr. Wallace-Sanders for November 2020; and, several faculty indicated interest in incorporating the exhibition into fall instruction.

At Oxford's request, all the Emory Libraries were included in the implementation of Aeon, the integrated special collections and archives request management system already in use at Rose Library and many other institutions of Emory's size. The system will allow Oxford to make archives and special collections more readily available to Emory and outside researchers and to retain request data for future reference. Further, Aeon will integrate with the upcoming ArchivesSpace Public User Interface development and the migration of the Emory Finding Aids database, giving Oxford researchers a much improved special collections discovery and request experience.

Collaborate with College departments and the other Emory Libraries to improve library and technology services for students and faculty. (Directly supports building a World Class Academic Experience, Mapping Pathways of Academic Excellence & Emory Libraries Roadmap: Infrastructure and Services)

- Provide support for faculty and student digital scholarship initiatives.
- Collaborate with the Emory Libraries Core Systems Team to implement an improved new discovery system, Blacklight, for accessing library resources.
- Improve library website and plan for a total website redesign

Collaborate with other Emory Libraries on the development of the Emory University Archives and Digital Library Program to expand access for students and faculty to the extensive physical and digital resources of the libraries. (Directly supports building a World Class Academic Experience & Emory Libraries Roadmap: Infrastructure and Services)

- Expand and enhance access to Oxford College Archives collections through implementation of the ArchivesSpace public user interface and integrated Aeon request system.
- Serve as collection stewards for the historic Oxford College catalogs during Phase II implementation of the Digital Library Program *Cor* Repository, as well as coordinate digital preservation of *The Emory Phoenix* and *The Oxford Spokesman* for inclusion in Emory Digital Collections.
- Develop the Oxford Research Scholars *Visual Narratives of Early Emory Student Life at Oxford* project with Tasha Dobbin-Bennet to preserve the digitization and description efforts of the first two cohorts in the Repository and on an Omeka project site.



Unique Sessions by Oxford User Type (June 2017-May 2020)


